## Consequences for misuse of cell phone

1st Offense Cell phone confiscated

2<sup>rd</sup> Offense Loss of permit for 1 month

3<sup>rd</sup> Offense Loss of permit for the remainder of the year.

Saturday School

Loss of privilege (game, dance, etc.)

Loss of permit means you cannot have a phone at school.

The term "cellphone" means any device that may be used for calling or texting. Junction Elementary provides Chomebooks, tablets, and computers for student use. Students are not permitted to use non-school devices during school hours.
